4514	Opening of the meeting. <i>Chairman</i> The Chair thanked everyone for coming and welcomed Fleetwood Moves Present: Chairman Councillor Cheryl Raynor, Councillors D Shaw, J Kurukavadua, M Moliner and A Jones In attendance; Shirleyanne Munro, Town Clerk and RFO, Dan Munro, Estates Supervisor
4515	To receive apologies for absence. <i>Chairman</i> Apologies received and recorded for Councillor K Nicholson, R Raynor, H Swatton and A Craig Not present or apologies submitted; Councillors M Belshaw, C Smith, J Martin and C Stephenson
4516	To record Disclosable Pecuniary Interests from members (including their spouses, civil partners, or partners) in any item to be discussed. Committee members MUST NOT make representations or vote on the matter therein. <i>Chairman</i>

4518	To hear the Grant Aid Application from Helen Gould and James Adams on behalf of Fleetwood Moves, who are asking for a grant of £2062 – Chairman HG thanked the Council for hearing their application. Their event is being held on July 4th, at the Marine Hall (with the indoors being used as a rain back up option), with groups from within Fleetwood and surrounding suburbs attending. Additional investment has been secured from Lancashire County Council and Sport England which will help Fleetwood Moves deliver a series of preparatory workshops involving Fleetwood Fusion and Neuro-Moves Cleveleys.

	The full amount was proposed by Councillor J Kurukavadua Seconded by Councillor D Shaw Approved by all present.
4519	To ask the Council to note and agree the quote provided by Neil Harrison, current contractors at Warrenhurst, for the next phase of refurbishment – Chairman, Estate Supervisor and Town Clerk DM gave a tour of the refurbishment work that was taking place in the new Council office space, with a detailed plan as to what the next phases were. An overview of the ladies toilets and the new flooring and cubicles that were being installed was given also. The Council were asked to consider and approve the quote for £7571.85 submitted for continuing works. Proposed by Councillor D Shaw Seconded by Councillor J Kurukavadua Approved by all present. The Chairman then asked those Councillors present to consider and approve using Neil Harrison and Co as preferred contractors to continue the work at Warrenhurst. This was overwhelmingly approved by those present. It was noted that it would still be required to go to Full Council for final agreement. ACTION: To be presented at next meeting. The Councillors noted that the Council staff have a provisional move in date of July 31st.
